<p><b><u>Penalties for late submission (excluding Postgraduate Flexible programmes)</u></b></p> <p><b><u>Penalties for late submission for Postgraduate Flexible programmes</u></b></p>	<p>(a) To provide clarification on the application of penalties when <b>Group Work</b> is involved – “Where the work submitted late is a piece of groupwork submitted on behalf of the whole group, the penalty will apply to all members of the group. Individual contributions to groupwork submitted separately by each member will be subject to a late penalty only for the individual contributions that are late.”</p> <p>(b) The Board agreed that approved amendments (setting the late penalty period at three working days, capping late penalties at the pass mark, and introducing a one-minute grace period) should be applied in cases where assessments were set either in, or prior to, the 2023/24 academic session, but where the due date is in the 2024/25 academic session.</p> <p>(c) Updates to indicate how assessments marked as “Pass/Fail” should be treated under the terms of the policy.
